DISCUSSION:

Golf Courses:

Exec. Dir. Meyers discussed the two golf course management contracts that expire in December 2020. The Meyer Family Management Company at Hughes Creek stated they do not wish to continue. The District proposed an extension for 1 year, which was declined. Meyers proposed another option, to offer GolfVisions Management an amended agreement that would include an extension for 1 year to operate Hughes Creek.

Commissioner Lenert stated he was in agreement with the proposed amended agreement. Chair Davoust felt this was the right direction rather than attempting to submit an rfp during a process of construction, this would be a difficult task. Commissioner Hanson asked who would be overseeing and managing the restaurant and the course itself. Meyers responded that GolfVisions has the staff and the experience, they manage other large golf properties in Illinois as well as other states. Hanson stated that it was important to have someone established to offer a higher standard of operation. There was consensus among the Committee to propose an amended agreement to GolfVisions.
